Prior to embarking on her professional journey, Ms. Orsak graduated summa cum laude from the University of Houston with a Bachelor of Business Administration in accounting. She subsequently earned a Doctor of Jurisprudence from Duke University School of Law in 1999, after which she was admitted to practice law by the Texas Bar Association and the U.S. District Court for the Southern District of Texas.
